

Credentialing Applicants Status Update for the Week of May 7, 2012

To search for your PIN in this document, you must put your PIN into the blank box in the PDF menu at the top of this document. If you do not have a blank box at the top of the document, you can press the CTRL key and the F key (CTRL and F) at the same time so that the "Find" dialogue box appears. After you have put your PIN in the blank box, you must hit the "Enter" key. Your cursor should now be at your PIN in the list.

If your status reads "we have received and accepted the documents we needed to begin your assessment" this means that your assessment has begun and your file is in the process of assessment. While your file is being assessed you will not see your status change very frequently as there will not be any new information to give you. You will only see your status change towards the end of your assessment, when we assess the level and focus of your education or the content of your education. You will also see your status change once your results are released and mailed to you. Please note that we are currently finalizing results for precedent files in approximately 20 weeks from the inventory complete date. Non-precedent files are currently being finalized in approximately 47 weeks from the inventory complete date.

A precedent 'file type' means we have assessed someone with the same course of education as you, graduating in the same year, from the same program, and under the same assessment standards.
